# **NOTIFICATION**

## SUBJECT: <u>SECURITY ARRANGEMENTS OF PUBLIC/ PRIVATE</u> <u>TECHNICAL/VOCATIONAL/COMMERCE INSTITUTIONS</u>.

The Home Department, Government of the Punjab, vide letter No. SO(IS-II)/3-3/2008(Bldg) dated 19-10-2009 (copy enclosed) has issued instructions to the Police Department, all the Divisional Commissioners and the District Coordination Officers for making necessary arrangements against the present threats of terrorism. The following measures **SHALL** be ensured in all Technical, Vocational & Commerce institutions (Government & Private):-

#### 1- Categorization of Technical/Vocational/Commerce (Government & Private):

- i. **CATEGORY** A : All GCTs/GPIs/GCCs/GITs.
- ii. **CATEGORY B:** All other Technical/ Vocational/Commerce Institutions.

### 2- <u>GENERAL SECURITY MEASURES APPLICABLE TO ALL CATEGORIES</u> <u>OF INSTITUTES.</u>

- i. Holding Parent Teacher Meetings for sharing responsibility regarding security and safety of students/ schools.
- ii. Sensitization of students about their role during crises/ security arrangements.
- iii. Civil Defence Training of students, teachers etc. and ensure rehearsal in consultation with Civil Defence Department.
- iv. Ensuring the duty of Chowkidars and other class-IV employees in uniform, and I.D Card with photos. Their duty rosters may be in a written format. (All Class-IV) employees especially Chowkidars to be got vetted/ checked through special branch of police department).
- v. Institutes Buses not to be operated.

- vi. Rescue plan to be chalked out and ensure participation in the seminar being arranged by the District Coordination Officers at district level on terrorism.
- vii. In case of any emergency, police may be informed immediately.

#### 3. <u>Special arrangements Category-A Institutions</u>.

- i. Raising the Boundary Walls up to 8-feet at least.
- ii. Deployment of Security Guards/ Police Guards at the gates in coordination with Local Police Authority.
- iii. Fixing of barriers in the passages/ entry/ exit points.
- iv. Arrangements of Security C.C.T.V. Cameras.
- v. Arrangements of Walk through Gates.
- vi. In case of any emergency, police may be informed immediately.

#### 4. Special Measures for Category-B Institutions.

All six arrangements stated in para-3 above except CCTV Camera, Walk through Gates and Armed Security Guards (Security Guard without arms however be ensured).

This may be assigned <u>High Top Priority</u> and ensure coordination with local administration, police, community and other allied departments for implementation of above referred points in letter and spirit. The Heads of Institutions, Zonal Managers and District Managers concerned will be held responsible in case of any security lapse.
