a. Preamble:

Students are nursery of the society and future leaders of the country and require special attention for creating awareness against corruption. Character building societies of students in educational institutions can play important role in strengthening of ethical and moral attributes in general and awareness against the menace of corruption in particular.

b. Objective:

- i. Inculcation of high moral and ethical standard, unity, faith & discipline.
- ii. Services to humanity in the hour of need.
- iii. To act as whistle blower against social evils, malpractices and corruption without any greed of benefit and exploitative design.
- iv. Promotion of professional ethics among students of professional and technical institution.

c. <u>Implementation methodology to achieve the objectives:</u>

Character building societies to be established in GCTs / GCCs / GICs / GTTIs.

d. <u>Organization / composition of implementation unit in field offices / institutions and their duties.</u>

- i. Patron-in-Chief: Head of the institution
- ii. Chief organizer: Faculty member to be nominated by patron-in-chief who will be responsible for functioning and formulation (on yearly basis) of society, coordination for arranging activities and achievement of tasks assigned to society.
- iii. Composition of society: Following positions of society will be filled by institution from amongst the students in order of seniority and merit of academic performance.
 - 1) President
 - 2) Vice President
 - General Secretary
 - 4) Members (as required)

f. <u>Activities of Character Building Societies</u>

- i. Display of code of conduct for students on all prominent places of the institution to achieve the above mentioned objectives highlighting ethical and moral values like honesty, integrity, rule of law, self discipline, truthfulness, punctuality, hard work, service to humanity etc.
- ii. One liner message displayed on fortnightly / monthly basis to attract attention of on-lookers.
- iii. The society may arrange debate / tutorial discussions on quarterly basis among students on topics mentioned above and lectures / speeches by inviting renowned scholars, academicians and senior officers including NAB on the relevant topics to strengthen the attributes of character building.
- iv. Declamation contests, essay writing competition, printing / poster competition on corruption and accountability on the occasion of International Anti Corruption Day observed on 9th December every year.
- v. Offering volunteer services to society in epidemics, flood / rain or any other disaster in association with local administration.
