- 7. The successful bidder is required to deposit performance security @ 10% of the contract amount in accordance with Section "S6" Chapter "08" of PPRA-2014. The performance security shall be deposited through CDR/ Pay order /Demand Draft /Bankers Cheque in the name of Project Officer Govt. Vocational Training Institute, (W) (RMGTC) Faisalabad.
