- i. Remuneration of all courses will be paid according to the given rates whereas practical periods will be paid @ 50% for all courses.
- ii. Remuneration shall be paid according to the prescribed qualification of the post as mentioned in TSR 2011/Curricula.
- iii. The regular staff engaged in evening shift/2nd shift shall be paid at half of the above mentioned rates if teaching before normal working hours by completing his/her designated workload. However, he/she shall be paid at full rate after the normal working hours.
- iv. All other clauses of Notification No. TEVTA/Deeni Madaris/84-2009 will remain intact.
