- The regular staff engaged in evening shift/2<sup>nd</sup> shift shall be paid at half of the above-mentioned rates if teaching before normal working hours by completing his/her designated workload. However, he/she shall be paid at full rate after the normal working hours.
- All other clauses of Notification No. TEVTA/Deeni Madaris/84-2009 dated 01.01.2013 & No. TEVTA/Fin/B&A/Short/2008 dated 02.09.2008 will remain intact.


