Subject: **ADMISSION POLICY FOR GCTs – (2012 -13)**

No. TEVTA/GM(O)/12-12/1368 In super session of previous notifications on the subject, following admission policy for admission in Diploma of Associate Engineer (DAE) course at Government Colleges of Technologies (GCTs) shall be instituted/observed for the Academic Year 2012-13:

1. Merit shall be observed in admissions irrespective of shifts/program. Three merit lists would be displayed at Notice Boards of the institute separately for each shift.
2. No admission will be made against donation, sports, co-curricular activities.
3. Each GCT shall give advertisement of DAE course and the tentative date for admission of reserved quota of TEVTA employee's sons and G-II / G-III certificate holder candidates will also be given in the advertisement.
4. Following eligibility criteria for admission would be observed:
 - a. The candidate must have passed the Secondary School Certificate Examination of the Board of Intermediate and Secondary Education/University in Pakistan or any other examination recognized as equivalent to the aforesaid examination with elective Mathematics, Physics, Chemistry and English and should have been declared pass in these subjects.
 - b. The merit of the candidate will be finalized on the basis of marks obtained in the subjects of Physics, Chemistry, English and Mathematics.
 - c. The upper age limit of the male candidate for the admission in DAE is 18 years in the Morning shift. Principal of the concerned institute may grant one year age relaxation and shall give a report in this regard to District and Zonal Manager. Similarly, age relaxation of three (3) years shall be admissible to Hafiz-e-Quran and Principal Concerned shall be the authority. Age limit for second shift/R-2 would be 28 years.
 - d. The upper age limit of the female candidate for the admission in DAE is 22 years in the Morning shift. Principal of the concerned institute may grant one year age relaxation and shall give a report in this regard to District and Zonal Manager. Similarly, age relaxation of three (3) years shall be admissible to Hafiz-e-Quran and Principal Concerned shall be the authority. Age limit for second shift/R-2 would be 28 years.
 - e. Candidates having domicile of any District of Punjab including Islamabad, will be eligible to apply for admission.
 - f. The candidate seeking admission in DAE on the basis of TEVTA employee's son/daughter quota will attach a service certificate along with last salary slip of his/her father/mother (*as the case may be*) verified from

the respective head of Institute/office where working and will apply directly to the concerned head of Institute for admission.

- g. Nomination of the candidates of Azad Jammu Kashmir, Gilgit Baltistan, FATA and other provinces will be made by their respective nomination Boards.
- h. Extra twenty (20) marks will be awarded to Hafiz-ul-Quran candidate after qualifying Hafiz-ul-Quran test by the committee constituted for the purpose. At least two members of the Hafiz Committee will also be Huffaz. In case if Hafiz-ul-Quran is not available in the institute, same may be invited from nearby TEVTA institute.
- i. Extra twenty (20) marks will be awarded to those students who have passed Industrial Art subject (wood work, metal work, electrical, Computer or equivalent) in Matric.
- j. Candidate seeking admission on the basis of Matric Tech/Matric Vocational will get 20 extra marks for deciding his merit for admission in DAE.
- k. The candidate should be physically and mentally fit. A medical fitness certificate will be deposited with the documents.
- l. In case a candidate conceals facts, does not present required certificate, makes wrong entries intentionally or un-intentionally. His application may be rejected. His admission would be cancelled at any stage whenever it comes to the knowledge and it will not be challengeable in any Court of Law.
- m. Following distribution of seats would be observed for admission in DAE irrespective of shift:

<u>Quota</u>	<u>Percentage</u>
1) All Punjab	85%
2) AJK/FATA/Gilgit Baltistan	03%
3) Armed Forces (Army, Navy, Air Force, etc) nominated by GHQ	02%
4) TEVTA Employee's son/daughter (in service or retired)	05%
5) G-II/G-III Certificate holder Candidates	03%
6) Other Provinces	02%%

Total (on merit basis) = 100%

- 7) Disable (*Over & above the total seats. However, merit will be observed among the competitor's*) 02%
- 8) Minorities (*other than Merit*) 05%

- n. Following other parameters shall also be applicable:

- 1) The candidates possessing G-II / G-III level certificate from the respective trade testing board must have passed Matriculation with Science.
- 2) In case of two candidates having otherwise same merit; *the merit will be made on the basis of total obtained Matric marks. If the total Matric marks of the both candidates are same, the older candidate within age limit will be admitted.*
- 3) After admission, the change of Technology would not be allowed in any case.
- 4) Admission of reserved quota of TEVTA employee's son/daughter and G-II/G-III candidates must be completed before regular admission, so that the remaining seats can be converted to open merit at the time of Regular admission. Principal is authorized to convert these remaining vacant seats to open merit.

- 5) In any condition, no admission/application form for DAE will be accepted / entertained after the due date.
 - 6) The Technology will be allotted on the basis of merit cum given priority in the admission form (*where his merit falls*) at the time of Interview.
 - 7) The selectee shall be required to pay admission dues at the spot, otherwise his seat shall stand canceled and next candidate on merit will be allowed to get admission on that said seat and the candidate failed to deposit dues will have no rights for admission in that session and this decision will not be challengeable in any court of law.
 - 8) O-Level candidate may apply for admission to DAE on open merit after converting their aggregates/grades in Science Subject (Physics, Chemistry & Mathematics) and English into marks from Inter Board Committee of Chairman (IBCC) for admission to DAE in GCTs Punjab.
 - 9) If the last date of deposit of registration and sports fee in PBTE (*without late fee*) is over, then the student admitted on drop-out vacant seat will have to pay the dues as per rules of PBTE, Lahore.
 - 10) Candidates seeking admission on minority basis must attach certificate (*on letter head*) from their respective religious centers in their vicinity.
 - 11) Candidates seeking admission against disable seats must attach Certificate issued by District Medical Board.
- o. Three merit lists should be displayed at Notice Boards of the institute separately for Morning and R-2 Shifts.
- p. ZMs shall submit merit lists of all institutes under their jurisdiction to Operations wing for information and record by September 30 each year.
- q. Since, there is a provision of one year age relaxation in GCT/GPI and Principal of the concerned institute is competent to grant age relaxation, therefore, no reference should be made to TEVTA Secretariat in this regard. No further extension shall be granted.
