NOTIFICATION

Subject: GRANT OF 20% ADHOC RELIEF ALLOWANCE-2012 FOR TEVTA AND PSIC EMPLOYEES.

No. TEVTA/Bud/Ad-hoc/2012/1454 Technical Education and Vocational Training Authority is pleased to grant 20% Adhoc Relief Allowance-2012 for PSIC and TEVTA employees from its own sources with effect from 1st July-2012 as under;

2. **TEVTA Employees**

20% Adhoc Relief Allowance-2012 shall be admissible on the running basic pay of TEVTA Pay Scales w.e.f. 01-07-2012.

3. PSIC Employees

20% Adhoc Relief Allowance-2012 shall be admissible on the running basic pay of Basic Pay Scales-2011 w.e.f. 01-07-2012.

- 4. The Adhoc Relief Allowance-2012 shall be subject to the following conditions:
 - i) Will be subject to income tax.
 - ii) Will be admissible during leave and entire period of LPR except during extra ordinary leave.
 - iii) Will not be treated as part of emoluments for the purpose of calculation of pension/gratuity and recovery of House Rent.
 - iv) Will not be admissible to the employees during the tenure of their posting/deputation abroad.
 - v) Will not be admissible to the employees on their repatriation from posting/deputation abroad at the rate and amount which would have been admissible to them had they not been posted abroad.

5. The term "Basic Pay" for the purpose of Adhoc Relief Allowance-2012 will also include the amount of the personal pay granted on account of annual increment (s) beyond the maximum of the existing pay scales.
