- V. Verification of qualification of all teaching posts BS-14 to BS-17 to be inducted as per TSR-2011.
- VI. Focusing to wards filling those posts / vacancies for which we are offering any courses. Thus eliminating the possibility of filling redundant posts.
- VII. Looking into the ranking criteria.
- VIII. Rationalization of recruitment plan and vetting of each post.
- IX. Recommendations for the proposals of National Testing Service Marks.
