- f. Teachers deputed on duty by the authority or by Training Section shall perform /attend relevant duty / designated training course.
- g. Summer vacations will not be availed by the Institutes mentioned at Sr. # 2 & 3.
- h. The Director (Training) / District Directors may place the staff at Sr. # 2 & 3 in the Institutes of their choice for teaching in their respective disciplines if required.
