## **TERMS AND CONDITIONS**

- 1. A E-Bid Notice and bidding documents are available on PPRA Punjab website <u>https://ppra.punjab.gov.pk</u> on e-Pak Acquisition & Disposal System (EPADS) Punjab <u>https://eprocure.gov.pk</u>.
- 2. The Contractor/ firm must be GST & NTN Registered. In case of exemption, proof should accompany the quotations.
- 3. Quotations are valid for minimum 45 days.
- 4. Quotations/bids prepared in accordance with the instructions in the bidding documents must be submitted through e-Pak Acquisition & Disposal System (EPADS) only uptill 27.01.2025 at 11:30 AM. The bids will be opened on same day i.e. 27.01.2025 at 12:30 PM through EPADS in presence of bidders.
- 5. Bids submitted by any other means than EPADS/by hand/hardcopy will not be entertained/considered and accepted.
- 6. Earnest money in shape of Bank CDR/DD/PO in the name of "Principal, Government College of Technology, Rahim Yar Khan" @ Rs.5% must be submitted separately for each technology as mentioned against each in the table. Combined CDR shall not be accepted.
- 7. The CDR of the estimated amount of each category must be attached/uploaded while applying for bid through EPAD system and the original instrument must be submitted in college before due date and time of opening of bid i.e. on or before 27.01.2025 at 12:30 PM.
- 8. **Performance security @10%** will be deducted from the items whom it will be applicable.
- 9. Payment will be made through cross cheque after deduction of all type of taxes as per prevailing rates. Inspection and acceptance of the items must be in accordance with the given specifications.
- 10. Payment will be released subject to the satisfactory inspection of Purchase committee
- 11. Rates must be inclusive of all taxes payable by supplier.
- 12. The procuring agency may reject all bids or proposals at any time prior to the acceptance of bids or proposal as per prevailing PPRA rules.
- 13. Attested Copies of active NTN,GST and PRA certificates must be attached/uploaded at the time of bid submission.
- 14. The Quotations must be submitted separately for each technology/package with separate CDR.
- 15. Black listed firms need not to apply.
- 16. All assessments and procuring procedure will be governed by the Punjab Procurement Rules (PPRA) 2014 and its amendment from time to time.
