1. The tender on items rate, based on Market Rate System (MRS) 2nd Bi 2024 (Finance Department Punjab), are invited *as per PPRA E-Tendering System* from the contractors/firms for enlisted from Pakistan Engineering Council registered for current financial year 2024-25 for the mentioned below AR/SR works at Govt. Pak German Polytechnic Institute for Agriculture Technology Chak 5-Faiz, Multan.
 2. The contractors/Firms who have to be registered on *Punjab PPRA website (www.punjab.eprocure.gov.pk)* any information/procedure regarding registration can be seen/obtained from website PPRA Punjab.
 3. The registered contractors/firms have to upload the earnest money amounting to Rs:283,060/- in form of CDR/ Pay Order / Demand Draft etc. in favoring the **Govt. Pak German Polytechnic institute for Agriculture Technology**, Chak 5-Faiz, Multan and submit bids on the website upto half hour before the opening date and time of opening of tender. However, original CDR has to be submitted to the tender opening committee on the same day, half hour before the opening of bids otherwise, the firm/contractor will disqualified in presence of tender opening committee.
 4. The contractors/firms may submit bids through *EPADS upto 09:00 AM on 28.02.2025*, where all bids will retrieved i.e. *28.02.2025 at 09:30 AM* and quoted rate successful bidder will be announced in the presence of Tender Opening Committee at in the office of PROJECT DIRECTOR PGICA Chak 5-Faiz Multan.
- In case of submission of any fake information/document such as CDR/receipt, the Contractor/Firm will disqualify from the current tendering procedure and will black listed to participate in any tendering process. Further recommendation to PPRA and PEC will also be made against such firm/contractor for appropriate action/black listing.
6. Tender type would be Single Stage – Single Envelope and bid validity is 90 days after bid opening date.
 7. The subject tender is available at PPRA, E-PAD and TEVTA website.
 8. The procuring agency may reject all bids or proposal at any time prior to acceptance of Bid or proposal under PPRA Rule-35 (Rejection of Bids).The procuring agency shall upon request communicate to any bidders, the grounds for its rejection of all bids/proposals but shall not be required to justify those grounds.
