3. E-bids must be submitted through E-Procurement on or before 07.04.2025 till 1:00 pm. Proposals must be accompanied by a Bid Security Rs. 35106/- in the form of Demand Draft, Pay Order or Call at Deposit duly issued from a Scheduled Bank of Pakistan.
4. E-bids will be opened on 7.04.2025 at 1:30 pm in the presence of bidders or their representatives. If bid closing/opening date falls on local/national holiday, the date of bid closing/opening shall be the next working day on the same time and venue
5. The bidders are required to give their best and final prices (inclusive of all applicable Taxes)
6. Bids not complying with the requirements shall be rejected being nonresponsive. Alternate proposals and / or conditional bids shall be considered non-responsive.

8. Bids which are incomplete, not E-bids, not signed and / or not stamped, late or submitted by other than specified mode will be rejected.
9. The contract shall be awarded to the lowest evaluated bidder.
