- Tender documents uploading on PPRA website, download the bidding documents from PPRA website, attested copies of updated renewal of PEC registration certificate/C&W / PWD, NTN Certificate, authority letter on the Pad of Contractor / firm, copy of CNIC of Contractor/Managing Partner of the firm, power of attorney and affidavit that the firm is not black listed form any Govt., Semi Govt. Department.
- The Contractor / firm must be GST & NTN Registered (both Federal Board of Revenue and Punjab Revenue Authority). In case of exemption, proof should accompany the quotations.
- 3. Bids are to be submitted up to 3rd May, 2025 (Any cutting or overwriting will not be accepted) till 11:00 AM and tender will be opened at 12:00 PM on the same day in front of AR/SR committee, intending contractors or their representatives.
- Tender Rates and Amounts should be filled in figures as well as in words and tender should be signed as
 per directions given in the tender documents. No rebate on tendered rates will be accepted.
- 5. The earnest money (2% of Estimated Price) must be deposited with Tender in shape of CDR/DD/PO/Banker's Cheque from any scheduled Bank in favor of the Principal, Govt. Technical Training Institute Kamalia.
- Any lowest bidder quoting rates below 5% shall deposit up to 5% of the estimated amount of tender as "Performance Security" in the shape of CDR, which will be returned / refunded upon successful completion of work.
