- 1. The Tenders through EPADS for Annual Repair / Special Repair are invited under single stage one envelop method at Govt. Technical Training Center (M), Kangan Pur from reputed and financially strong firms for the below work. The Firms / Bidders having the valid registration with Pakistan Engineering Council (PEC), Punjab Revenue Authority (PRA) and Federal Board of Revenue (FBR) for NTN are encouraged to participate in E-bidding. The estimate is based on "MRS 2nd Bi-Annual 2024".

- 3. The bid security @2% must be reached in the form of Pay Order / CDR / Demand Draft / Bankers Cheque in favor of "Govt. Technical Training Center (M), Kangan Pur" on or before 20-05-2025 (10:30 AM), failing to do so will be considered non-responsive and the bidders will be considered unsuccessful.
