- Interested bidders having Home Department Active Income Tax and sales tax registered at FBR and PRA respectively, may get the tendered item's specification immediately after publication of this tender from the PPRA website / EPADS (E-Pak Acquisition and Disposal System) <https://punjab.eprocure.gov.pk>.
- Single stage, two envelopes basis bidding procedure shall be applied.
- Proposals/bids are to be submitted only electronically through EPADS till 1:00 PM on 12-06-2025 and Technical bid shall be opened in the presence of authorized representatives of firms/ contractors (As per PPRA Rule) at office of Principal Government College of Technology (M) PAF Road Sargodha at 1:30 PM on 12-06-2025. Financial Bids Shall be opened later on. After evaluation of Technical Bid, time & date of opening of financial bids will be conveyed in writing to technically qualified bidders only.
- The Company must be GST/PRA & NTN Registered & also have incorporation certificate from SECP. Valid NOC from Ministry of Interior Pakistan/ Home Department Govt. of the Punjab In case of exemption, proof should accompany the tender.
- The Bid Security / Earnest Money (2%) Rs. 89000/- in the form of CDR / Bank Draft/Pay Order in favor of "G.C.T. Sargodha Non Salary Account" is required to be submitted before 1:30 PM on 12-06-2025 at the office of Principal GCT (M) Sargodha.
- Bid security /earnest money must be delivered/provided in original well before the opening of bids i. e. (12-06-2025 at 1.30 PM) otherwise the defaulter bidder will be considered Non response & his bid will be rejected as per PPRA rules.
- Current minimum Wages rates fixed by the Govt. of Punjab & TEVTA for the category "Security Guards" must be followed as per Punjab Gazette.
