

Applications along with CV, attested copies of all Educational Testimonials, Experience Certificates, Domicile, copy of CNIC & 01-Passport size Photograph must reach at the mentioned below address through registered mail / courier service or by hand latest by 24-06-2025 (Tuesday) 03:00 PM. The interviews of only eligible Candidates will be held on 27-06-2025 (Friday) at 10:30 AM in the office of Principal Govt. Vocational Training Institute (W) Chunian.
- 2. The Certificates & Degrees must be from recognized Board, University or Institution.
- 3. Only post qualification relevant experience will be considered.
- 4. No separate call letter will be issued for interview.
- 5. The Eligible candidates will be informed for interview through Telephonic calls on given number.
- 6. The applications received after due date will not be considered.
- 7. At the closing date of application, the applicant's age should be 18 to 40 years for Trade Instructor Beautician and 18 to 35 years for Sweeper.
- 8. The candidates having the **Domicile of Division Lahore will be preferred for Trade Instructor and the candidates having the Domicile of District Kasur only** can apply for sweeper.
