The bids through EPADS for Annual Repair / Special Repair are invited under <u>Single Stage Single Envelop</u> procedure at Govt. Technical Training Institute, Gujranwala, from reputed and financially strong firms for the below mentioned work. The Firms / Bidders having the valid registration with Pakistan Engineering Council (PEC), Punjab Revenue Authority (PRA) and Federal Board of Revenue (FBR) for NTN are encouraged to participate in E-bidding.

- 1. The Bidding Documents are available for download via EPADS / PPRA & TEVTA websites (<u>www.ppra.punbjab.gov.pk</u>) (<u>www.tevta.gop.pk</u>) free of cost.
- 2. All PPRA Rules must be followed and bidders must submit their bids only via e-Pak Acquisition & Disposal System (E-PADS) <u>https://punjab.eprocure.gov.pk</u>
- 3. The bid security @2% must be reached in the form of Pay Order / CDR / Demand Draft / Bankers Cheque in favor of "**Principal, Govt. Technical Training Institute, Gujranwala**" on or before 30-07-2025 (10:30 AM), failing to do so will be considered non-responsive and the bidders will be considered unsuccessful.
- 4. The date of e-bids closing is <u>30-07-2025 at 10:30 AM</u>; the e-bids will be opened on the same day in the Office of Principal / Govt. Technical Training Institute, Gujranwala at <u>11:00 AM</u> in the presence of District AR-SR Committee and bidders (who chose to be present).
- 5. Bidders are advised to ensure uploading the e-bid on e-PADS Portal, well before the E-Submission deadline, and not wait for the last date and time to upload the e-bid. E-Bid E-Submission on E-PADS Portal shall entirely be the responsibility of the bidder.
- The procuring agency may reject all e-bids at any time prior to the acceptance of a bid and shall upon request communicate to any bidder. The grounds for rejection of e-bids shall not be required to justify by the Procuring Agency.
