- Bidders are advised to ensure uploading complete signed and scanned documents along with full bid security and Biding documents on E-PADS Portal, well before the submission deadline, and not wait for the last date and time to upload the bid. Bid submission on E-PADS Portal will entirely be the responsibility of the bidder. TEVTA shall not be held responsible for any issues thereof.
- Only Accumulative Rate for whole tender will be used to determine the lowest evaluated bidder.**
- Bidder/Contractor is bound to complete the work within 120 days after issuance of Work Order.
