Tenders/Bids/Item rates, based on "MRS 2 Bi-Annual 2024" are invited from reputable firms/agencies for said work at **Govt. College of Technology, Sangla Hill.** The Firm/Bidder must be registered with Pakistan Engineering Council, Punjab Revenue Authority and Federal Board of Revenue (NTN). In case of exemption, the proof thereof should accompany the bid(s).

- The tender document is available for download via EPADS / PPRA / TEVTA website free of cost.
 bid security must be reached in the form of Pay Order / CDR / Demand Draft / Banker's Cheque favoring "Principal, Govt. College of Technology Sangla Hill" on or before <u>08-09-2025</u>.
- Bids must be prepared in accordance with the instructions of the bidding documents, should be Submitted through e-Pak Acquisition & Disposal System (E-PADS) only up till 04-09-2025 at 10:30 AM
- 3. Bids submitted by any means other than EPADS will not be entertained / considered and accepted.
- 4. The bids will be opened on same day i.e. 08-09-2025 at 11:30 AM in conference room of the Govt. College of Technology, Sangla Hill through EPADS system, in the presence of the college AR-SR committee and bidders / representatives with the Power of atoner of the firm (if any).
- 5. A bid security (refundable) @ 5% Rs. 74,300/- total estimated cost of bid in the form of CDR/Pay Order/Demand Draft favoring "Principal, Govt. College of Technology, Sangla Hill" must be attached/uploaded at the time of submission of bid through EPADS. The original instrument for must be delivered / provided in original well before the opening time of bids i.e. (08-09-2025 at 10:30 AM) otherwise the defaulter bidder will be considered Non response & his bid will be rejected as per PPRA rules.
- 6. The successful bidder is required to deposit guarantee @ 10% of total contract amount within 07 days of the award of contract, in accordance with Section "56" Chapter "08" of PPRA-2014 in shape of DD/PO/CDR favoring "Principal Govt. College of Technology Sangla Hill". After receipt of guarantee the Work order will be issued. In case of non-submission of guarantee @ 10 % of the contract amount within 07 days of the award of contract, the bid security may be forfeited and contract will be terminated.
- 7. The procuring agency reserves the right to increase or decrease the quantity of any items, subject to the total amount of the tender.
- 8. Tender type would be Single Stage One Envelope.
- 9. The procuring agency may reject all bids or proposals at any time prior to the acceptance of an any bid or proposal, the grounds for its rejection of all bids shall not be required to justify those grounds, as provided under Rule-35 of Punjab Procurement Rules, 2014.
- 10. Erasing, cutting/ overwriting should be avoided. However, if any, the same shall properly be signed
- 11. In case of public holiday announced by the government on the bid opening day, bid will be opened on the next working day.
- 12. Procurement Method: Open Competitive bidding.

- 14. Bid validity is 60 days.
