## TENDER NOTICE FOR PROCUREMENT OF TRAINING MATERIAL

Bids are invited through e-Pak Acquisition & Disposal System (E-PADS) under single stage one envelope item wise procedure from eligible bidders/firms/contractor registered for income tax and sales tax with the Government bodies/ departments, for the procurement of training material for the following trades (Computer Information Technology & Dress Designing & Making) at the Govt. College of Technology (W), Gujranwala under prevailing PPRA rules.

- 1. Tender notice and documents are available on PPRA Punjab website <a href="https://ppra.punjab.gov.pk">https://ppra.punjab.gov.pk</a> and on E-PADS Punjab link <a href="https://eprocure.gov.pk">https://eprocure.gov.pk</a>.
- 2. The bidders/firms/contractors must be active tax payer for NTN and GST. In case of exemption, the proof thereof should accompany the bid(s).
- 3. Bid rates should be written in figures as well as in words on the bid form.
- 4. The bids prepared in accordance with the instructions in the bidding documents should be submitted through e-Pak Acquisition & Disposal System (E-PADS) only up till 24-09-2025 at 10:00 hours.
- 5. Bids submitted by any means other than EPADS will not be entertained/considered and accepted.
- 6. A bid security (refundable) in the form of CDR/Pay Order/Demand Draft favoring "Principal, Govt. College of Technology (Women), Gujranwala" must be attached/uploaded at the time of submission of bid through EPADS. The original instrument for bid security must reach/submitted at the below mentioned address prior to bid opening date and time i.e. 24-09-2025 at
- 7. All the prevailing Govt. taxes are to be paid by the firms /contractors as per policy/rules of the PPRA/Govt. Transportation and installation charges would be carried by the firm/ contractor, therefore the rates should be quoted inclusive of all taxes, installation charges as well as transportation/freight charges.
- 8. The successful bidder is required to deposit performance guarantee @ 10% of total contract amount within 07 days of the award of contract, in accordance with Section "56" Chapter "08" of PPRA-2014 in shape of DD/PO/CDR favoring "Principal Govt. College of Technology (Women) Gujranwala". After receipt of performance guarantee the procurement order will be issued. In case of non-submission of performance guarantee @ 10% of the contract amount within 07 days of the award of contract, the bid security may be forfeited and contract will be terminated. The performance guarantee will be refunded after the defect liability period expiry which would be 01 year starting from successful completion (full delivery & complete installation) of work and after submission of satisfactory report of concerned committee.
- 9. Income tax, GST and any other Govt. tax (if applicable at the time of delivery) will be the responsibility of the bidder.
- 10. The procuring agency may reject all bids or proposals at any time prior to the acceptance of bids or proposal as per prevailing PPRA Rules.
- 11. Attested copies of active NTN and GST status must be attached /uploaded at the time of bid submission.
- 12. Erasing, cutting/ overwriting should be avoided. However, if any, the same shall properly be signed
