Bids are invited through **e-Pak Acquisition & Disposal System (E-PADS)** under **single stage one envelope** procedure from eligible bidders / firms registered for income tax and sales tax with the Government bodies/ departments, for procurement of Machinery, Equipment & Tools for Shuttering & Scaffolding Trade under prevailing PPRA rules.

1. Tender notice and documents are available on PPRA Punjab website <https://ppra.punjab.gov.pk> and on E-PADS Punjab link <https://eprocure.gov.pk>.
2. The bidders/firms/contractors must be active tax payer for NTN and GST. In case of exemption, the proof thereof should accompany the bid(s).
3. **Only Accumulative Rate for the whole tender will be used to determine the lowest evaluated bidder.**
4. Bids must be prepared in accordance with the instructions of the bidding documents, should be Submitted through e-Pak Acquisition & Disposal System (E-PADS) only up till 11-02-2026 at 01:00 PM.
5. Bids submitted by any means other than EPADS will not be entertained/considered and accepted.
6. The bids will be opened on same day i.e. 11-02-2026 at 01:30 PM in conference room of the Govt. College of Technology, Bhakkar through EPADS system, in the presence of the college procurement committee and bidders/representatives of the firm (if any).
7. A bid security (refundable) @5% **Rs. 101,394/-** in the form of CDR/Pay Order/Demand Draft favoring **"Principal, Govt. College of Technology, Bhakkar"** must be attached/uploaded at the time of submission of bid through EPADS. The original instrument for bid security must reach/submitted at the below mentioned address prior to bid opening date and time i.e. **11-02-2026 at 01:00 PM.**
8. All the prevailing Govt. taxes are to be paid by the firms /contractors as per policy/rules of the PPRA/Govt. Transportation and installation charges would be carried by the firm/ contractor, therefore the rates should be quoted inclusive of all taxes, installation charges as well as transportation/freight charges
9. The successful bidder is required to deposit guarantee @ 10% of total contract amount within 07 days of the award of contract, in accordance with Section "56" Chapter "08" of PPRA-2014 in shape of DD/PO/CDR favoring **"Principal Govt. College of Technology Bhakkar"**.
10. Income tax, GST and any other Govt. tax (if applicable at the time of delivery) will be the responsibility of the bidder.
11. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal, as provided under Rule-35 of Punjab Procurement Rules, 2014.

12. Attested copies of active NTN and GST status must be attached/uploaded at the time of bid submission.
13. Erasing, cutting/ overwriting should be avoided. However, if any, the same shall properly be signed.
14. In case of public holiday announced by the government on the bid opening day, bid will be opened on the next working day.
15. Bidder is bound to deliver the goods within 15 days after issuance of Procurement Order.
