4. Original Bid Security Instrument must be submitted in an envelope clearly marked with the Bidding Document Number and Title, before the E-bid Submission deadline in the Office of Principal, Govt. Vocational Training Institute (W), Dev Samaj Road, Lahore.


5. Bidders are advised to ensure uploading the Bid on E-PADS Portal, well before the submission deadline, and not wait for the last date and time to upload the bid.
