

**TENDER NOTICE**  
**TEVTA SECRETARIAT, LAHORE.**  
**Single Stage two Envelope**

TEVTA Secretariat, 96-H Gulberg-II, Lahore intends to invite the bids for the following below mentioned work through PPRA E-Tendering system, the tenders based on item rates on approved BOQ are hereby invited from the contractors / firms enlisted / renewed / active with Punjab E-PAD, PEC, FBR, and PRA for the current financial year in the relevant category (C4 & above) and specialization/ professional codes in Civil and Electrical Category along with the undertaking on stamp paper worth Pak.300/- that firm is not blacklisted by TEVTA. The contractor shall produce the original PEC license having mentioned the requisite relevant specialization codes and category C4 & above at the time of opening of tender. The contractor not having the relevant specialization code will not be entertained into further process.

1. The procurement is to be carried out through E-PADS (E-Pak Acquisition and Disposal System) <http://punjabeprocure.govt.pk> website of Punjab Procurement Regulatory Authority (PPRA). All interested applicants / constructors are required to register on E-PADS to become eligible for participation. Tender Notice / Tender Document containing detailed requirements, terms and conditions are available for the registered bidders on EPADS at <http://punjab.eprocure.gov.pk> and Punjab Procurement Regulatory Authority (PPRA) website <http://ppra.punjab.gov.pk>.
2. The tender documents comprising the BOQ must be submitted on E-PADS based on item rates as per the date and time mentioned below. Manual bids shall not be accepted.
3. Every page of the bid shall be signed and stamped by the contractor. All the pages of the uploaded bid should be readable. Unreadable or partially unreadable / incomplete bids will be rejected. The bidders are required to fill all the columns of bids mentioning the amount of each item and complete bid amount at the end.
4. The URL of the website of the PPRA (<https://eproc.punjab.gov.pk/activetenders.aspx>) and response time shall be calculated exclusively from the date of publication of advertisement on the website of the PPRA.
5. The prospective bidders must submit the bid security in favor of Chairperson TEVTA in the form of a CDR / Bank Draft / Cashier's Cheque of any scheduled bank/pay order for the amount mentioned against work.
6. The contractors / bidders shall produce the original CDR / Bank Draft / Cashier's Cheque/ Pay Order in the favor of Chairperson TEVTA physically well before the bid submission time.
7. Conditional tenders and tenders not accompanied with earnest money/bid security shall be rejected. The online-submitted bids / tenders will be opened on the website on fixed date and time in the office of procurement section TEVTA by the respective Committee, in the presence of contractors or their representatives having authority letter.
8. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal as per PPRA Rules. The procuring agency shall upon request communicate rejection to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids proposals, but it is not required to justify those grounds.
9. The performance guarantee shall be obtained from the lowest bidder in the light of Clause 56 of PPRA Rules, along with 10% of contract amount.
10. The standard execution form/terms and conditions followed by C&W, is used/applicable for the said work.
11. The selection will be made on accumulative cost based followed least cost method after fulfilling all the basic requirement mentioned above.
