- 1- Catering contract Hostel mess terms and conditions along with responsibilities of Vendor.
- 2- General structure for Mess Menu.
- 3- Rules pertaining to the daily functioning of the mess.
- 4- Penalties for violation of mess rules.
- 5- Rates are valid for the Academic session 2026-27.
- 6- The competent authority may reject all bids, or proposals, at any time prior to the acceptance of bid, or proposals.
- 7- The earnest money (refundable after completion of Academic Session 2026-27) @ Rs.5% of the estimated price will be deposited by the bidder with the bidding documents through DD/PO in the name of "G.C.T SARGODHA NON SALARY ACCOUNT".
- 8 The bidding documents can be downloaded from the website of PPRA <http://ppra.punjab.gov.pk>.
- 9 Bid validity period of 120 days.
- 10 The contract will be enforced for a period of one year.
- 11 **Bid security /earnest money must be delivered/provided in original well before the opening of bids i. e. (03-08-2026 at 1.30 PM) otherwise the defaulter bidder will be considered Non response & his bid will be rejected as per PPRA rules.**
Note: - Bidders are advised to ensure uploading the Bid on E-PADS Portal, well before the submission deadline. Bid submission on E-PADS Portal shall entirely be the responsibility of the bidder. GCT (M) Sargodha shall not be held responsible for any issues thereof.
