Technical Education & Vocational Training Authority (TEVTA) invites bids through **Single Stage – One Envelope National Competitive Bidding Procedure** from active tax-paying bidders, duly registered with the **Income Tax and Sales Tax Departments** and registered on **E-Procurement System** (<https://ep.punjab.gov.pk/>) **for the financial year 2026-27**, for the **Procurement and Installation of Machinery, Equipment & Tools**.

- The bid(s) prepared in accordance with the instructions mentioned in the respective procurement activity's Bidding Document, must be submitted through [E-P System] at <https://ep.punjab.gov.pk/> by or before 10:30 A.M hours PST on the closing date **(05-09-2026)** for respective procurement activity mentioned above. The bids will be opened at **11:00 A.M** hours PST through E-Procurement System (EP system) on same day for respective procurement activity in the presence of bidders or their representatives who shall choose to attend the bids' opening session to be held in office of the **Principal Govt. Vocational Training Institute for Women Chakwal**.
- All Bids must be accompanied by a Bid Security of 5% of the estimated cost, to be deposited electronically through the facility available at Punjab e-Procurement System (EP System).

- Bidder will have to submit the Bid security on [EP System] by or before **10:30 A.M** on the closing date other-wise the tender of the bidder will stand cancelled and will be considered as non-responsive. Bid Security will be released after completion of evaluation process.
- The quoted rates in the bids must be item wise and clearly readable. Furthermore, incomplete, Ambiguous and unfilled bids would not be entertained and considered as rejected.
- The Competent Authority may reject all bids at any time prior to the approval / acceptance of the Tender rates under **PPRA Rules-2014, Chapter VI, Clause-35**.
- When Acceptance letter is issued to the successful contractor, he has to make the agreement with department on stamp paper of value specified by Government within seven days for issuance of Procurement Order.
- Bidding document is also available on PPRA Punjab website.
- In case of submission of any fake or forged document, the Contractor/ Firm would be disqualified / blacklisted.
- Non-responsive, Non-Readable, Corrupted, Virus Infected, Non-Signed & Non-Stamped bids shall be rejected.
- Bidders are advised to ensure uploading the e-bid on e-procurement System (EP System), well before the e-bid submission deadline, and not wait for the last date and time to upload the e-bid. E-Bid submission on **(E-Procurement system)** shall entirely be the responsibility of the bidder. **Govt. Vocational Training Institute for Women Chakwal** shall not be held responsible for any issues thereof.
