1. Tender notice and documents are available on PPRA Punjab website <https://ppra.punjab.gov.pk> and on E- Procurement System (EP System) link <https://ep.punjab.gov.pk>.
2. The bidders/firms/contractors must be active tax payer for NTN and GST. In case of exemption, the proof thereof should accompany the bid(s).
3. **Only Accumulative Rate for the whole tender will be used to determine the lowest evaluated bidder.**
4. Bids must be prepared in accordance with the instructions of the bidding documents, should be Submitted through E- Procurement System (EP System) link <https://ep.punjab.gov.pk>. only up till **19-09-2026 at 11:00 AM.**
5. Bids submitted by any means other than EP System will not be entertained/considered and accepted.
6. The bids will be opened on same day i.e. **19-09-2026 at 11:30 AM** in conference room of the Govt. College of Technology, Bhakkar through EP system, in the presence of the college procurement committee and bidders/representatives of the firm (if any).
7. A bid security (refundable) **@5% Rs. 71,700/-** to be deposited electronically through the facility available at Punjab E-Procurement System (EP System).
8. The bidder will have to submit the bid security on EP System by or before **19-09-2026 at 11:00 AM** otherwise Tender of bidder will stand cancelled and will be considered as non-responsive.
9. All the prevailing Govt. taxes are to be paid by the firms /contractors as per policy/rules of the PPRA/Govt. Transportation and installation charges would be carried by the firm/ contractor, therefore the rates should be quoted inclusive of all taxes, installation charges as well as transportation/freight charges.
10. The successful bidder is required to deposit guarantee @ 10% of total contract amount within 07 days of the award of contract, in accordance with Section "56" Chapter "08" of PPRA-2014 in shape of DD/PO/CDR favoring **"Principal Govt. College of Technology Bhakkar"**.
11. Income tax, GST and any other Govt. tax (if applicable at the time of delivery) will be the responsibility of the bidder.
12. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal, as provided under Rule-35 of Punjab Procurement Rules, 2014.

13. Attested copies of active NTN and GST status must be attached/uploaded at the time of bid submission.
14. Erasing, cutting/ overwriting should be avoided. However, if any, the same shall properly be signed.
15. In case of public holiday announced by the government on the bid opening day, bid will be opened on the next working day.
16. Bidder is bound to deliver the goods within 15 days after issuance of Procurement Order.
